Appointment of Curtis Myers, President of Fulton Bank to serve on the Board of Directors of Tec Centro. After some discussion, a motion was made by Todd Eachus to ratify the approval of Curtis Myers to the Tec Centro Board of Directors, 2nd by Joanne Mathias, motion approved.

Strategic Discussions

Tec Centro: Marlyn Barbosa gave an update on her program with working on new programs and working on applying with the state to become a private school. She also spoke about the Culinary Arts program being updated to reflect more hands on in the Café, the Call Center curriculum is being updated, the CDL Ed training will host an open house on April 8th, and the STEM program is every other Saturday which has 20 students and is working out well.

Nuestra Clinica: Carlos gave an update on this program. Todd Eachus mentioned that Comcast Cares Day will be held at the Halfway House (134 Locust St) this year on April 22nd and will begin at 8am.

Education & Prevention: Sandra gave an update on her program. The client count is being increased. **Centro Hispano:** Yirmares gave an update on this program. The evening meals program has 2,074 registered. We serve 93 on average and have 106 new clients for this month. Misael Franqui gave an update on the Tiny Homes. A facebook page has been created to promote the homes, the name is Mi Casa Project, the homes will be used as a last resort

Broadcasting: Claudia gave an update on this program. Claudia is in contact with Juan Perez from the LPRC board. An audience measurement is being done for the LPRC. Surveys are being completed with the help of Millersville University. The Fiesta is May18th and the Marathon will be held the 1st weekend in April.
